what is RenewTech?*

RenewTech will keep your vehicle in showroom condition by fixing or repairing stone chips, minor dents, light scratches and other specified damage to your vehicle's interior and exterior. You don't have to make provision for unexpected restoration and maintenance repairs out of your own pocket, or claim from your motor comprehensive insurance policy.

how do you benefit?

- Keeps your vehicle in showroom condition for a small monthly fee
- Could optimise resale value
- Cosmetic maintenance and restoration work
- Reputable repairers
- Claims can be made every 90 days
- No need to claim from insurance
- Qualify for a paintwork treatment or air-con re-gas*

eligibility

- Private motor vehicles and light delivery vehicles with a gross vehicle mass of no more than 3 500 kg
- The RenewTech Plan may be purchased over 24, 36 or 48 months
- The maintenance and restoration must occur in the Republic of South Africa
- Motorcycles, caravans, trailers, canopies and vehicles used for racing and rallies are not covered

what does renewtech provide for?*

| Exterior solutions

- Light scratches smaller than 15 cm in diameter
- Minor dents not bigger than 15 cm in diameter and where the panel has not been ripped, perforated or torn
- Stone chips that may be filled and sealed to prevent corrosion
- Removes and restores tar spots and marks
- Maintenance and restoration of damage to your Renault's windscreen, headlamps and related glass components in case of repairable chips only
- Restoration of wheel rims and mag wheels if they sustain scuffs, stone chips or paint defects
- Replacement of wheel rims or mag wheels is excluded

|| Interior solutions

- Scratches or scuffs smaller than 15cm and 1mm deep to your Renault's centre console and dashboard
- Scratches or scuffs to the door panel plastic will be repaired and re-sprayed
- Tears or rips to your Renault's gear lever boot and handbrake boot
- Restoring faded paint on your Renault's gear knob
- Repair of tears and burn holes to your Renault's seat panel
- Repair of damaged seat stitching and sun visors
- If your Renault is fitted with safety film, the benefit provides maintenance and restoration for scratches, scuffs and tears caused by a sharp object or similar type damage only
- Scratches or scuffs to plastic door grab handles will be re-sprayed. Chrome plated and leather finished door handles are excluded
- Restoration of driver side's rubber carpet inserts. Loose mats and carpets are excluded
- Re-spraying of leather steering wheels, but excludes re-covering of steering wheels
